




The Professional Interest Area International Committee's Autumn Conference, hosted by the London/UK Chapter was an overwhelming success. The conference took place on September 16 through September. 19 and was attended by 187 delegates from sixteen different coun-

tries and sixteen different States from the US. The conference theme was 'Global Practice from an International Centre'. Presentations were made by 28 different speakers covering a broad range of views and opinions on international architectural practice. The conference began with a keynote speech by Sir Norman Foster who illustrated the international influence on his design in a compelling 40-minute talk. The morning's seminars featured presentations from representatives of both large firms and small firms practicing in London and on the Continent.

On the second morning, the conference moved to the RIBA Headquarters on Portland Place. Among the many discussions were presentations made by the AIA National President, Ronald Altoon, FAIA and Dr. Alex Reid, Director General of the RIBA. # Enter Design Competition by January 15th

Entries for the London/UK Chapter's fifth annual Excellence In Design Awards competition are due by 15 January 1999. The awards program recognises and honours excellence in architectural design:

- By-UK-based architects for projects anywhere in the world,
- By after the cts anywhere in the world for projects in the UK, or
- By UK-based students for projects in the UK.

Eligible projects may be structures, buildings or groups of either. Project type is not limited to new-build architecture. Rehabilitation, interior and monument designs are also welcome, and there will be awards in multiple categories.

Projects may be built or un-built work. They must be the work of licensed architects and have been designed between 1 January 1993 and 31 December 1998.

Any eligible architect or practice may submit any number of eligible entries so long as each is submitted separately with a fee of £25.00.

Architecture students may submit studio projects provided they are enrolled in an architectural program at the time of the submittal. <u>Student entries will be free of charge.</u>

Recipients of awards or commendations in the past three years include:

This year's jurists will be **David Nelson**, Chairman (Foster and Partners), **Nigel Coates** (Branson Coates Architecture Ltd), **Karen Cook** (Kohn Pedersen Fox), **Steven Hodder** (Hodder Associates), and **Rick Mather** (Rick Mather Architects).

The sole judging criteria will be design excellence. The jury is empowered to define the extent to which excellence is determined by aesthetic, social or functional characteristics. Its decisions will be based on material submitted; no field trips will be taken.

# How is the AIA Representing Overseas Members?

AIA Federal Affairs is devoting a larger portion of its resources to monitoring and advocating international trade and relations issues affecting architects. GATT and NAFTA and the possibility of passing Fast-Track legislation during the 1998 legislative session have dominated the international legislative discussions so far.

The AIA supports trade agreements that encourage open boundaries and free flow of products and services. The Fast-Track legislation will allow trade to increase with countries that have been wary of congressional influence and protectionism on trade.

The AIA is also interested in decreasing the taxes on income earned overseas by Americans (Section 911 of the US tax code), and advocating the appropriation of moneys for the Export-Import Bank, the Trade Development Agency, the Overseas Private Investment Corporation, and other funding programs housed by the World Bank.

It will advocate Fast-Track legislation and speak out against the use of unilateral sanctions as a foreign policy tool. If another tax cut is provided for in the next tax agreement, AIA also will be advocating a further reduction in taxes for income earned overseas.

## ARB and NCARB Open Talks on Reciprocity

ARB and NCARB met in Washingtton, DC, in October to discuss the possibilities of re-establishing reciprocity between the US and UK architectural community. The AIA and RIBA also sent representatives to the meeting. ARB Chairwoman Barbara Kelly was the primary ARB spokesperson, and RIBA representatives utilised in most-ARB presentations.

Both ARB and NCARB stressed that this first meeting was a "fact finding" meeting. The meeting followed a pre-determined agenda for two days and focused on detailed presentations, commentary and questions on both national systems related to architectural education, accreditation/validation, internships, and registration examinations.

ARB noted the ongoing changes they are making related to the validation of UK schools of architecture and the architectural examination. Their closure on these two issues will likely influence further bilateral conversations.

ARB representatives expressed their satisfaction at having an opportunity to learn about the U.S. systems at this point in their restructuring of the UK systems


