# First Annual AIA/London UK Design Awards

The First Annual AIA Excellence in Design jury met on the 6th of February, 1995 at the Royal Academy of Art, Piccadilly to select the 1995 AIA Design Award winners. The jury was led by Yann Weymouth AIA, Arup Associates, and included Chapter President Stephan C.

Reinke AIA, Sir Philip Dowson FAIA CBE, President of the Royal Academy, Ms Zaha Hadid, Architect, Mr David Leventhal AIA, Kohn Pedersen Fox, and Mr Rick Mather AIA, Architect.

There were a considerable number of entries reflecting British, American, and student spheres. Large corporate firms as well as sole practitioners submitted entries and the jury felt that "the submissions were of a very high quality".

Following rigorous review, three entries were chosen for the First Annual Excellence in Design Awards Program;

A Student Design Award, A Design Commendation, and the 1995 AIA/UK Design Award. These will be presented to the winners in a ceremony at New Zealand House on the 23rd of February. The Award winners will be on exhibit on that evening.

# AGM at New Zealand House

The second Annual General Meeting of the London/UK Chapter will be held on 23 February at 6:30 in the penthouse of this important modernist tower designed by RMJM. Rick Mather will be guest speaker.

The Chapter will elect new officers, and the Awards Committee will announce the winners of the AIA London/UK Design Awards.

Displays of the AIA National Design Awards will be on view. Refreshments and entertainment will be provided.

#### **President's Comment**

The last ten months have seen the growth and development of the First International Chapter of the American Institute of Architects.

#### New Views of Grosvenor Square

The first Design Charette to be held by the London/UK Chapter produced four awards in the categories of Best Adaptation of an Existing Building, Best New Building, Best Use of the Square, and Biggest Leap of Faith.

The 75 participants in the daylong event at the US Embassy were encouraged to create practical or fantasy alternatives to the existing building on Grosvenor Square.

The jurors were Nicholas Baskey, Minister Counsellor of Administrative Affairs at the US Embassy, Patrick Collins, AIA, of the Foreign Buildings Office of the US State Department, Paul Finch, Editor of the Architect's Journal, Robin Nicholson, RIBA, Vice President of RIBA, Sydney Sporle, Director of Planning & Environment of Westminster City Council and Daniel Smith, AIA RIBA, Vice President of the Chapter.

The prize for Best Adaptation of the Existing Building went to the team led by Lee Polisano, AIA RIBA, of Kohn Pedersen Fox. Design elements that favourably impressed the jury were the blasting out of the base of the building to create a transparent link through to the rear, where a garden atrium was formed by a further carving out of the Saarinen building. The visual linking of Hyde Park and Grosvenor Square (which acquired a baseball diamond) was particularly liked by the jurors.

Best New Building was won by the team led by Pierre Baillargeon of Hellmuth Obata Kassabaum. It used a large glazed atrium to separate the administrative and public portions of the building. The scheme also came complete with detailed floor plans, elevations and sections. Best Use of the Square/Most Optimistic was won by **Debbie Bentley**'s "Dream Team", while the Biggest Leap of Faith was awarded to a team of students from De Monfort University in Leicester. Their twin skyscraper towers provided the best image of the future.

The London/UK Chapter wishes to acknowledge the generous support of UDO Reprographics, who sponsored the event and ran off the contestants' prints fast and furiously throughout the day, and of the US Embassy, whose co-operation facilitated the event.

#### AIA in Hong Kong

William Chapin, president of the AIA, and other AIA members met colleagues from the corresponding organisations representing Hong Kong, Japan, Malaysia, China and Australia in Hong Kong in November. The conference was an important step in the collaboration of the various architectural institutes, according to Chapin.

Stephan Reinke, London/UK Chapter President, addressed the participants on "How to start an International Chapter".

The conference, which concluded in Shenzhen in the People's Republic of China, featured the work of AIA members and their experiences working outside the US

Representatives of the Architectural Society of China, the Chinese Institute, and National Board for Architect Registration of the People's Republic also spoke. It emerged that China is following to a great extent the example of the AIA in establishing its registration, education, ethics, professional practice, and associated activities.

# Weymouth named Chevalier

Yann Weymouth, AIA, senior designer at Arup Associates, has been awarded the Chevalier de l'Ordre du Merite by French President Mitterand.

He was honoured for his service to the Republic as I.M.Pei's chief design architect for eight years on the Grand Louvre project.

The Ordre du Merite was founded by Charles de Gaulle in 1961, to form a civil counterpart to the Legion d'Honneur, the French Republic's equivalent to a knighthood. The President of France is the head of the Ordre, which shares its headquarters with the Legion d'Honneur in the Hotel Salme on the left bank of the Seine.

"I get to wear a small blue ribbon in my lapel button-hole, which means little in the UK but a lot in France. I am thrilled," said Weymouth.

## Christopher Smallwood Architects

Christopher Smallwood trained at the Architectural Association 1964-1971, and after working for Skidmore Owings and Merrill in Chicago, formed this practice in 1976. Early work included several commissions for retail outlets, including showrooms for Piero di Monzi, The London Lighting Company and Oggetti.

More recently, the firm has worked on listed and historic buildings, both as high-end domestic remodelling to houses in London and environs and also on galleries and museums. They are the architects for the Walker Gallery, Liverpool, who prepared a master

plan for the reorganisation of the public facilities.

For some years, a substantial portion of their work has come from the US, mainly apartment and gallery remodelling in New York and houses on the East Coast.

Both Christopher Smallwood and his associate Jonathan Dinnewell have benefited from the reciprocal NCARB/ARCUK examination process (now defunct), and have joined the London/UK Chapter of the AIA.

The practice was recently invited to submit design proposals for the rebuilding of the areas of Windsor Castle which were destroyed in the 1992 fire. They are currently working on a masterplan for the general improvements at Goodwood House, a Grade 1 listed building in Sussex. Goodwood is currently run as a conference and entertainment facility as part of a house museum holding an important collection of pictures and furniture. It is also the private residence of the Earl and Countess of March.
