# Debating the Issues: The AIA London/UK Planning and Planning Law Seminar

The AIA London/UK Chapter hosted its second panel discussion and debate on the issues of UK and US Planning Laws and Planning Methods. Mr Roger Kallman Assoc. AIA and Co Chair of the Chapter Public Policy Committee acted as moderator of the debate which was held at Salomon Brothers Headquarters. Mr

Peter Rees, Chief Planning Officer for the Corporation of London, opened the evening with a presentation of his background and philosophy. He explained that his passion for design and indeed planning were derived from his "needs to touch and stroke other peoples buildings" and that his actual project experience as a young architect from Wales included "putting the balls on an historic building" and "placing the pale. narrow lines on Cornish streets". He compared the joy of encountering well

designed spaces to "an orgasmic experience". On a more serious note he stated it is the responsibility of architects and planners to determine the "shape" of our environment for the millennium.

Denzil Millichap, Planning Law Specialist and Solicitor for Linklaters & Paines, followed with a presentation describing laws and approaches to planning from different eras. One from 1925, described "three wise men" empowered to make decisions for the populace. In another model, from 1932, planning was community led with "the experts brought in to ensure good taste". "The debate is not new" stated Denzil "and one wonders how much we have improved since then!"

The method of planning in Moscow was described by Larry Malcic, AIA, a founding director of the Chapter. He explained a Moscow planning exercise was performed with the use of a 20 metre square wooden model, with a

sliding gantry overhead.
Recently an American
architect's proposal for an
80 storey tower was
rejected because it clashed
with the movement of the
gantry. Larry then
discussed the new
movement in the US toward
local design review boards
and cautioned that the
focus in planning should be
"what is allowed, not what
is prohibited".

Steven Spier, AIA, an American lecturer in architecture and urban design at South London University, then decried the UK system as driven by politics rather than good design and community requirements. He raised the issue of participatory planning exercises and questioned the validity of laymen with no experience in design or planning, driving planning solutions. He also questioned the use of budget allocation as a divining rod for planning.

A "new work process" was explained by Mr John Thompson, RIBA, and a Community Planning leader, "to encompass the Consensus, Energy and

Participation of the local population" in planning the built environment. He noted that the cost for the Kings Cross planning exercise had been £34 million with no tangible benefit, stating that much in the way of approved planning and development was "driven by greed not need". He also gave examples of Green Belt mentality where current planning law prohibits the development of some of the best sites. He encouraged the participation of all parties with the guidance of professionals.

A lively and open discussion between panel members and the audience skillfully moderated by Roger Kallman, Assoc. AIA, followed and focused primarily on the debate of issues surrounding participatory planning.

Larry Malcic, AIA, perhaps summed up the discussion best by quoting Yeats, whose verse states that the Duke of Urbino did not consult with the shepherds in the area when deliberating on planning matters and architectural design in Renaissance Urbino.

- Structures or buildings (or groups of either) of any type (including rehabilitations, interior design, monuments, etc) built or unbuilt, anywhere in the world by European based architects.
- Any project designed for or built in Europe by

- architects from anywhere in the world.
- Architecture students may submit studio projects, provided they are currently enrolled in an architectural programme in the United Kingdom.
- Projects must have been designed after January 1, 1992.

#### Criterion

The sole judging criterion is design excellence. The jury is empowered to define the extent to which excellence is determined by aesthetic, social and functional; characteristics. The jury may elect to honour projects without making any such distinctions.

#### Deadline

All submissions must reach the AIA prior to noon on Friday, November 24, 1995.

#### **Entry Fees**

Practising Architects: £50

Student entries: £15

Each submission must be accompanied by a cheque payable to:
American Institute of Architects
London/UK Chapter

Any eligible student, architect or practice may submit any number of eligible entries provided each is submitted separately with the appropriate fees for each.

#### Awards

Following the jury's selections, honourees will be contacted and invited to the awards ceremony. Award announcements will be made and certificates presented at the AIA London/UK Chapter Excellence in Design Awards Gala on the evening of December 7, 1995.

# 1996 Nominations Sought

The origin of Honorary Fellowship goes back to the beginning of the AIA. The Institute's constitution provides for recognition of distinguished international architects. The qualifications for Honorary Fellowship are: "An architect of esteemed character and distinguished achievements who is neither a U.S. citizen nor a United States resident and who does not practice architecture with the domain of the Institute." All members of

the Institute are encouraged to identify qualified candidates and bring them to the attention of their AIA director.

Nominations should be based on an architect's notable and outstanding contributions to architecture, society and the profession in the nominee's home country or internationally. The Objects of the Institute have been adopted as guidelines for the categories of achievement for nomination. Honorary Fellowship is granted to foreign architects who have:

- 1. Produced distinguished work through design, urban design, preservation, or practice of architecture.
- 2. Made notable contributions through their work in education, research, or literature.
- 3. Actively, efficiently, and cooperatively led the construction industry and their professional organization.
- 4. Made notable contributions to public service, or in government or industry service through leadership in

the development of civic improvements.

 Made notable contributions to the public good beyond the scope of normal professional activities.


